

Coronavirus Relief Grant Application

Jefferson College received Coronavirus Response and Relief Supplemental Appropriations Act (CRRSAA) funds for emergency financial aid grants to students.

Unlike Coronavirus Aid, Relief, and Economic Security (CARES) Act grants, which were limited to students with expenses connected to the 2020 disruption of campus operations or a move to online learning, CRRSAA funds are available to support Jefferson College students struggling to cover any component of their cost of attending college or for emergency expenses that have arisen due to the coronavirus.

Also, degree and certificate-seeking students, as well as non-degree seeking, non-credit, dual enrollment, and continuing education students participating in spring or summer 2021 courses may apply for a CRRSAA emergency financial aid grant. Initially CRRSAA funds were limited to U.S. citizens and eligible non-citizens. Effective summer 2021, eligibility was expanded to include Jefferson College's international students.

Higher Education Emergency Relief Fund (HEERF) rules stipulate that students with exceptional need, often documented through completion of a Free Application for Federal Student Aid (FAFSA), receive priority awarding. This application is not a guarantee that you will receive a grant.
