Berry Endowed Scholarship: Restricted to Jefferson County residents demonstrating financial need. Non-Renewable.

<u>Big River VFW #5331 Ladies Auxiliary Endowment Scholarship:</u> Recipient must be a graduating senior, past graduate student or GED/HiSet recipient whose primary attendance center is Grandview, Hillsboro or Northwest High Schools. Non-Renewable.

Bryan Gilbert Memorial Scholarship: Restricted to students demonstrating financial need with 3.0 GPA - enrolled in Music, Art, Drafting, Engineering or Teaching. Renewable w/ 3.0 GPA.

<u>Jack & Janet McLard Scholarship:</u> Recipient must be enrolled in CIM and/or HVAC. No minimum GPA. Renewable.

<u>Jack Cronin Memorial Baseball Scholarship:</u> Recipient must be a baseball player graduating from Jefferson County high school, enrolled full time. Renewable if full time.

<u>James Yelton Sr. Memorial Scholarship:</u> Recipient must be enrolled in Theater or Communications coursework; full-time with financial need. Requires 2.5 GPA. Renewable with 2.5 GPA.

<u>Jane Houser Endowed Scholarship:</u> Recipient must be a Jefferson County resident demonstrating financial need. Renewable with 2.5 GPA

RE Harris Memorial Nursing Scholarship: Recipient must be enrolled in a nursing program w/ financial need. Non-Renewable.

Richard Bell Starlight Chorus Choral Scholarship: Vocal majors only enrolled full time with 3.0 GPA. Renewable if full time and meeting GPA requirements.
