Automated Phone System	Ray reminded Team members to let the Information Technology Director know if the Automated Phone System routes any calls incorrectly so IT can address it. Since the last conversation on this topic, phone calls have been routed much more suitably.	
SSP/PREP Software	Chris mentioned the PREP system for case management, paths to completion, and student support currently being used in grant programs and with some advisors. He has been a proponent of scaling it to all advisors; however, the company has not done any software development over the last few years, making PREP non-viable as long-term technology solution. Chris met with Mark Smreker to discuss Degree Works from Ellucian. The cost to rollout would be a \$100,000 up-front, but only \$17,000 per annually to maintain. If technology like this helps to retain 25 students in the first year, it will have paid for itself. The Guided Pathways Task force on Technology is looking at solutions such as Degree Works as part of the Technology component. Team discussed the importance of vetting any software product to ensure it has strategic value. The conversation is in the very early stages. A consideration for any technology update with an upfront cost: what part of the budget will be surrendered in the short-term to pay for the innovation? FURTHER DISCUSSION NEEDED	
Technology Funding	Team discussed funding models for technology; there is not a system outside of Capital Projects for approval of technology projects/innovations.	

With the Capital projects budget reduced to \$500,000, there could be some money set aside for technology-only initiatives that could be approved by a standing subcommittee of Strategic Planning. Some initiatives that have been discussed but no decision or timeline for implementation has been determined: chat bot, keyless entry, FLAC, Bring Your Own Device. These initiatives need long-term implementation plans, including training and technical literacy. There are many stand-alone plans, but the College is missing and integrated strategic plan that would take all of these items into consideration. There needs to be a process to evaluate technology updates more globally instead of one at a time. **FURTHER DISCUSSION NEEDED College Reading Prep.** Northwest high school reached out to Allan to talk about offering an Early Course College Reading course. Chris, Allan, Lisa Ebert, several Northwest administrators, and a lead counselor form Northwest met to discuss possibilities. The College would be partnering with Northwest to share curriculum and provide testing for their students. Kaysie Dudley has been instrumental in developing relationships with Northwest this year. Northwest estimates 100-120 students who are primarily on a technical career track who could benefit from a College Reading Preparation course. The course would be for Junior and Senior year students and would allow students to gain their reading proficiency while in high school. Using multiple measures for English, these students could come to Jefferson College ready for college courses. Allan would like to try a pilot of the program with Northwest and scale it to other schools if it is successful. The group also discussed Industrial Math and GUD101 offerings. If students could complete Industrial Math, GUD101, and Reading Proficiency in high school, they would have close to one semester of credit when they enroll at Jefferson College. **FURTHER DISCUSSION NEEDED** Daryl sent the Campus Acronyms List from the Employee Support Committee to **Acronyms List** Team for final review. It has been reviewed by supervisors, committee chairs, and constituent leads. The list will be posted on MyJeffco for employee access and given to new employees in their initial meeting with the HR Specialist. Team will provide changes and additions via email to Miriam. **ACTION:** 1. Team members email any additions or changes to Miriam by Friday, December 6. **Budget** Associate Dean of MPT Hiring Maryanne Angliongto and Adam Tournier were the top candidates; Meet and Greets with the finalists were on October 20. Substantial feedback was received from the Meet and Greet attendees. **Planning Updates on Strategic** Enrollment is up 4% as of November 26. It will most likely level out, as spring **Enrollment Management** enrollments tend to drop.

- For FAST Budgeting and Forecasting, Millennium wants to go live the first part of December. Training will most likely begin in January.
- Daryl mentioned that during the IRS audit, they were reminded that tuition reimbursements over \$5,250 in one year is taxable income unless the education is required by the employer or the law, or it maintains approved skills for the job. There were two employees this year that exceeded the \$5,250 amount; Daryl will send out the list of tuition reimbursements and ask for supervisors to state that it is related to their jobs. Team suggested adding a checkbox on the reimbursement paperwork to make employees aware that over \$5,250, it may become taxable if the education is not related to their current job. It is not to discourage reimbursements or education, but simply to determine taxability.
